2. That I have been notified of my right to receive counseling at the expense of the prospective adoptive parent. I understand that I may exercise this right until six months after the birth of my child. I understand that I may also waive this right to counseling.
3. That I have been advised that if I withdraw this consent, the prospective adoptive parent cannot require me to reimburse any costs the prospective adoptive parent has incurred in connection with the adoption, including payments made to or on behalf of myself.

That I understand:

I may, for any reason, withdraw this consent to adoption within the next ten working days from the date hereof; My withdrawal of consent must be in writing and must be received by this agency no later than the tenth working day following the date upon which this consent is executed and acknowledged;

My consent will become irrevocable on the day following the tenth working day from the date hereof, except upon and order of the court of competent jurisdiction after findings that the consent was obtained by fraud.
