# **Band Assembly Weekly Update: Week of May 3-7, 2021**

Tuesday, May 4, 2021: Legislative hosted a Pre-Band Assembly meeting to discuss the agenda items. Prior to Pre-Band Assembly Legislative hosted a MOCK Session of Band Assembly. Approval of Minutes: April 28, 2021. Reports and Presentations: None. Unfinished Business: Legislative Order 32-21 (Band Assembly Recordkeeping Procedures). New Business: Band Assembly Bill 19-03-38-21 (Amending Title 3), Band Assembly Bill 19-03-39-21 (Appropriation Bill), Band Assembly Bill 19-03-40-21 (Appropriation Bill), Resolution 19-03-57-21 (Grant proposal for Geniigaanizijig), Resolution 19-03-58-21 (Lakeshore Property), Nomination David Sam – DI Associate Justice Position, 6 Community Development Construction Contracts, 3 HHS Provider Agreements, 2 HHS Foster Care License, and Hardship Request – D2. - a) **Band Assembly Bill 19-03-38-21:** A Bill amending Title 3 of the Mille Lacs Band Statutes ("MLBS") for the purposes of removing Robert's Rules of Order, adding a definition section, adding a section to clarify when a bill, order, and resolution becomes effective, and adding language to ensure clear language throughout.

**Sponsor: District I Representative.** Bill was introduced, read, and approved.

b) **Band Assembly Bill 19-03-39-21:** A Bill of Supplemental Appropriation and Budget Revisions for Administration and Health & Human Services for the Fiscal Year Ending September 30, 2021.

Sponsor: District II Representative. Bill was introduced, read, and approved.

- c) **Band Assembly Bill 19-03-40-21:** A Bill of Supplemental Appropriation for Natural Resources for the Fiscal Year Ending September 30, 2021.
  - **Sponsor: District III Representative.** Bill was introduced, read, and approved.
- d) **Resolution 19-03-57-21:** A Resolution Approving the Submission of a Grant Application to the Minnesota Department of Human Services Office of Economic Opportunity for the Community Services Block Grant and Minnesota Community Action Grant Package. Resolution was approved with a waiver of the formal reading.
- e) **Resolution 19-03-58-21:** A Resolution Declaring that the Band Assembly Will Not Consider for Approval Any Leases of Lakeshore Property Until the Enactment of a Fee Lands Leasing Code Consistent with the Best Interests of the Band. Resolution was tabled.
- f) **Nomination:** A nomination, from Chief Executive Benjamin, for David Sam to serve as the District I Associate Justice position pursuant to 5 MLBSA § 5.b. Current term expires August 15, 2026. Roll call vote requested and nomination passed.
- g) **Contract (CMD):** A contract for Cobra Construction to provide labor and materials for the renovation of the former Mille Lacs Marine building in District I. Contract end date is September 30, 2021. Contract was approved.
